NOTICE WILL BE MAILED ON THE FIRST BUSINESS DAY OF THE MONTH WITH AMOUNT DUE AND A SHUT OFF DATE IF NOT PAID.**
5. Customer may cancel services by signing a cancellation form, or service may be cancelled after thirty (30) days' written notice, unless otherwise waived by the Village. (Vacant or empty properties will be charged monthly until service is cancelled.)
6. Neither this application, nor the service supplied, shall be assignable or transferable.
