

ORDINANCE NO. 673

AN ORDINANCE TO AMEND ORDINANCE 3-1009 CONCERNING GAS CONSUMER RATE FOR CONSUMERS OF GAS THROUGH THE VILLAGE OF PENDER, NEBRASKA; REPEALING ORDINANCES IN CONFLICT; AUTHORIZING PUBLICATION IN PAMPHLET FORM; AND ESTABLISHING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF PENDER, NEBRASKA:

SECTION 1. That the Village of Pender hereby establishes new gas consumer rates as set forth below.

SECTION 2. All Ordinances and parts of Ordinances, passed and approved, prior to the passage and approval of this Ordinance, and in conflict herewith, are hereby repealed.

SECTION 3. This Ordinance shall take effect and be in full force from and after its passage, approval and publication in pamphlet form or posting as required by law, to be effective for the billing period commencing May 1, 2022.

SECTION 4. Village Ordinance 3-1009 shall be amended as follows:

3-1009 **Municipal Gas Department; Minimum Rates:**

All said consumers shall be liable for the hereinafter designated rates, unless the consumer directs the Utility Superintendent, by written order, to shut off the gas in which case said consumer shall not be liable thereafter for new charges for gas until the gas is turned on again. Monthly rates are as follows, to-wit:

GAS

RESIDENTIAL/RURAL/SMALL COMMERCIAL

Customer Monthly Base Charge: \$15.00 per month.

Cost of the Commodity plus an additional 20% added to Commodity charge/monthly charge
November through April.

Meter Fee \$5.00 per month

Should the Village Board vote to provide said services to a customer outside of the corporate limits, whether or not within the zoning jurisdiction of the Village, all costs of installation of said service shall be borne by the customer. Said service shall be provided at a rate 15% higher than the above-referenced rates for the service charge and usage. The meter fee shall be \$5.00 per month.

COMMERCIAL

Customer Monthly Base Charge: \$20.00 per month.

Cost of Commodity plus an additional 20% added to Commodity Charge/Customer monthly charge.

Meter Fee \$10.00 per month.

Should the Village Board vote to provide said services to a customer outside of the corporate limits, whether or not within the zoning jurisdiction of the Village, all costs of installation of said service shall be borne by the customer. Said service shall be provided at a rate 15% higher than the above-referenced rates for the service charge and usage. The meter fee shall be \$10.00 per month.

GAS (INTERRUPTIBLE)

Customer Monthly Base Charge: \$40.00 per month.

Cost of Commodity plus an additional 20% added to Commodity Charge/monthly charge
November through April.

Meter Fee \$10.00 every month.

Should the Village Board vote to provide said services to an interruptible customer outside of the corporate limits, whether or not within the zoning jurisdiction of the Village, all costs of installation of said service shall be borne by the customer. Said service shall be provided at a rate 15% higher than the above-referenced rates for the service charge and usage. The meter fee shall be \$10.00 per month.


This applies only to Pender Public School, Pender Community Hospital and Pender Grain Company.
